TELEPHONE FRANCHISE ORDINANCE No 19.

An Ordinance granting to the Deertrail Telephone Association, a corporation, its successors and assigns, a franchise to construct, establish, extend, maintain, and operate a telephone system or systems, in the Town of Deertrail, Arapahbe County, State of Colorado, for the purpose of serving the public and its customers with telephonic accomodations, and to charge and collect rents, tolls, and charges therefor.

BE IT ORDAINED by the Board of Trustees of the Town of Deertrail, Colorado:-

Section 1:- The word"Grantee" when used in thes ordinance shall denote the Deertrail Telephone Association. Section 2:- The term"Telephone system" as used in this Ordinance

Section 2:- The term"Telephone System" as used in this Ordinance shall denote each and every part of a complete telephone system consisting of poles, wires, cables, conduits, telephones, exchange systems, switchboards, electricia and magnetic appliances, instruments, apparatus, force, power, and all other apparatus and equipment necessary for the operation of a telephone system, and for the maintenance of the same.

Section 3:- The said grantee is hereby granted a franchise for the period of Twenty years, from and after the date of the approval of this Ordinance, with full right, power and authority, to construct, establish, extend, maintain, and operate a telephone sestem or systems and all appurtenances necessary thereto, within the present or future corporate limits of the Town of Deertrail, and to buy and otherwise acquire, establish, maintain, carry on, operate, furnish and suply, sell, lease, and deal in telephones, telephonic lines, telephonic exchange systems, and telephonic and other electricle and magnetic appliances, instruments, apparatus, force, and power, for the purpose of furnishing telephonic services and accomedations to the citizens of said Wown, and the public, and to charge and collect rents, telephone business through, upon, over, and under the streets, all ys, and other public grounds of the Town of Deertrail, Colorado, and said grantee is given the right to enter upon and use the streets, a lleys, and other public grounds of said town, and to place and maintain thereon and therein, such poles, wires, cables, conduits, and other apparatus, and applianes as may be necessary and proper, and the right to excavate trenches therein and lay cenduits and the right to trim trees when necessary to prevent them from coming in centact with wires, subject to the terms and conditions hereinafter mentioned and provided.

Section 4:-All poles and wires shall be erected and placed in such manner and places as will, consistent with necessity, least interfere with the other public uses of said streets, alleys, and other public places, and the said streets, alleys, and other public places shall not be unnecessarily obstnucted during such erection, and shall within a reasonable length of time be placed as nearly as practicable in as good condition and repair as before such construction at the ex ense of the grantees. Such poles and wires shall, when placed in the streets, be placed at a uniform distance from the property line, to be designated by the Board of Trustees, and when placed in the alleys, be placed one foot from the property line, except poles in the streets in the business district shall be placed just within the curb line, and no poles shall be placed on Main Street except at Street and Alley intersections without the consent of the Board of Trustees.

Section 5:-The grantee, whenever it becomes necessary for any person to move along or across any of said streets of alleys, with any vehicle or structure of such height and size so as to interfere with any poles or wires so erected, shall, upon receiving twenty-four hours notice, served in writing upon its agent or manager at Deer Trail, Colorad, and upon meceiving payment of the actual cost thereof, temporarily remove such poles and wires from such places as must necessarily be crossed by such vehicle or structure.

Section 6:-The grantee shall protect the Town of Deertrail, Colorado, against any loss or damage arising because of the construction or operation of aaid telephone system by an indemnity bond of Two Thousand pollars (\$2,000.00).

Section 7:-The Board of Trustees shall pass such ordinances as shall be necessary for the protection of the grantee in the rights herein granted.

Section 8:-This Ordinance, after its passage, shall be recorded in a book kept for that purpose, be authenticated by the signatures of the Mayor and Clerk, and shall be published in the Deertrail Tribune, a newspaper published within the limits of the Town of Deertrail, and shall take effect and be in force upon the expiration of five days after it has been so published.

The Board of Trustees of the Town of Deer Trail, Colorado, met in special called session at the regular place of meeting in the Town Hall, on Monday evening July 18th, A. D. 1921, at 8:00 o'clock P. M.

At which meeting there were present and answering to roll call Mayor Hugh Anderson, Trustees Wm. Kingsbury, D. M. Titus, T. H. Wobermin, A. J. Cummins, Fred Baker, Absent Trustee J. T. Carmack. Also present, Fown Clerk R. L. Bloss.

There being a quorum present the following business was transacted.

Trustee Fred Baker introduced an Ordinance relating to Misdemeanors within the corporate limits of the town of Deer Trail, and providing for punishment for violation of its provisions, which ordinance was entitled,

"AN ORDINANCE RELATING TO MISDEMMEANORS", and is as follows:

Be it ordained by the Board of Trustees of the Town of Deer Trail, Arapahoe County, State of Colorado.

Section 1.-- No person shall be drunk or in a state of intoxication in any highway, street, or alley or other public place within the limits of the town of Deer Trail, Colorado, nor be drunk and disorderly, or in a state of intoxication or under the influence of intoxicating, malt, vinous, mixed or fermented liquors and disorderly in any public or private place within the limits of the said town.

No person or persons shall have in their possession on his or her person or premises or on any premises controlled by them, within the limits of the Town of Deer Trail, Colorado, any intoxicating, malt, vinous, mixed or fermented liquors unless he or she have the legal right thereto as shown by the proper legal permits and **au**thortiy in his or her possession, which legal permits and authority shall on demand be produced by said person or persons, lacking which they shall be deemed guilty of misdemeanor under this ordinance and be subject to its penalties.

No person shall keep for sale or distribuition in any manner, any intoxicating, male, vinous, mixed or fermented liquors within the limits of the Town of Deer Trail, Colorado, in any public or private place, unless such person have the legal permit and authority to do so, which legal permit and authority shall be produced by them on **demand** from the authorities, lacking which they shall be deemed guilty of misdemeanor under this section, and be subject to punishment as provided herein-after.

Any person who shall violate any of the provisions of this section shall, on conviction, be fined in any sum not exceeding five hundred dollars nor less than fifty dollars, or be imprisoned in the city jail for a period of from one to thirty days, or shall be subject to both such fine and imprisonment, as may be adjudjed by the court, and the town marshall and all police officers or those upon whome any police powers are or may be conferred by any ordinance of the town of Deer Trail, Colorado, are hereby authorized and empowered and it is hereby made their duty to arrest or cause to be arrested, with or without process, any person or persons found violating any of the provisions of this section and commit such person or persons, to the town jail or other safe place, until sober if they be drunk, and at such time, or as soon thereafter as may be convenient, such person shall be taken before the Police Magistrate to be dealt with according to law, above penalties attaching to each and every offence.

Section 2-- No person shall, within the limits of the Town of Deer Trail, Colorado, have or keep any room or place, wherein gambling in any manner shall be carried on or be set up, or keep any keno table, faro bank, shuffle board, roulette table, playing cards or any instrument or instruments, device, or other things whatsoever with which any money or other articles shall in any manner be played for.

Any person, firm, or corporation, now having in its possession any slotmachine, punch board, or other device for playing at chance which they hold under contract with any firm or corporation, shall have thirty days after the passage of this ordinance to dispose of the same.

Any person violating any of the provisions of this section, on conviction, shall be subject to a fine in any sum not exceeding three hundred dollars, nor less than fifty dollars, or be imprisoned in the city jail for from one to thirty days, or may be gubject to both fine and imprisonment, as may be adjudged by the court, for each and every offence.

Section 3-- No bawdy house, house of ill-fame, house of assignment, or place for the practice of fornication or common, ill-governed, or disorderly house, shall be kept or maintained within the town of Deer Trail, Colorado, and any person who shall keep such house, or shall be an inmate, or in any way connected with such house, or contribute to it's support, and any person who shall permit any tenement, building or premises under his or her control to be used for any such purpose, and any person who shall permit any building to be used or occupied for any such purpose to stand upon any lot or parcel of ground within the town of Deer Trail, Colorado, and which is owned, possessed or controlled by him or her shall be deemed guilty of misdemeanor and shall on conviction be subject to a fine of not less than one hundred dollars and not more than five hundred dollars, or to imprisonment in the city jail from one to thirty days, or may be subject to both fine and imprisonment as may be adjudged by the court.

Section 4-- Any prostitute, courtesan or lewd woman who shall within the limits of the Town of Deer Trail, Colorado, by word, sign, or action, ply her vocation upon the streets, or at any public place or at the door or window of the house or room she may occupy or make any public meretricious display of herself upon the streets or in any public place in said town, shall be deemed guilty of a misdemeanor, and shall on conviction be fined not more than one hundred dollars for each and every offence, or may be confined in the city jail from one to thirty days, or may be subject to both such fine and imprisonment, as may be adjudged by the court.

Section 5-- If any person in the town of Deer Trail, Colorado, make, countenance or assist in making any improper noise, riot, disturbance, or breach of the peace, or shall use loud, profane, foul, obscene, or abusive language, or language calculated or tending to provoke a breach of the peace, every such person shall on conviction be fined in a sum not exceeding fifty dollars for each and every offence, or be confined in the city jail from one to thirty days, or may be both fined and imprisoned as may be adjudged by the court.

Section 6-- If any person shall within the corporate limits of the Town of Deer Trail, Colorado, carry concealed upon or about his or her person, any pistol, bowie knife, dagger or other deadly weapon, he shall on conviction be fined in any sum not exceeding two hundred dollars, or be confined in the city jail from one to thirty days, or be both fined and imprisoned as may be adjudged by the court, provided that this section shall not be construed to apply to sheriffs, constables, or other officers of the peace.

Section 7-- Any person who shall throw a stone or other missile against or in any way deface the walls or other parts of any building or buildings, whether occupied or unoccupied, within the limits of the Town of Deer Trail, Colorado, or who shall in any manner injure the awnings, awning posts, fence, enclosures, or other improvements of any character whatever, either public or private property, or who shall fill up; throw, or place other things in, obstruct, or otherwise damage any ditch or ditches, lawfully constructed in said town, or who shall injure, mark or deface any trees planted for the ornament or shade of the streets or private lots in said town of shall cut down, disfigure, mark, deface, distroy, or in any manner injure any tree, shrub, plant, enclosure, fence, bridge, or building, public or private, unless he is the owner thereof, or with permission of the owner thereof shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in a sum not exceeding fifty dollars for each and every offence, or be confined in the city jail from one to thirty days, or be both fined and imprisoned as may be adjudged by the court.

Section 8-- Any person who shall suffer any drunkeness, quarreling, fighting, unlawful games, or riotous or disorderly conduct on his or her premises within the limits of the Town of Deer Trail, C lo ado, shall on conviction be fined in a sum not exceeding fifty dollars for each and every offence, or be confined in the city jail from one to thirty days, or may be both fined and imprisoned as may be adjudged by the court.

Section 9-- No persons shall, within the limits of the Town of Deer Trail, Colorado, collect together in bodies or crowds for unlawful purposes, or for any purpose to the annoyance or disturbance of the citizens or travelers thereof. Any person violating any of the porvisions of this section shall, on conviction, be severally fined in any sum not exceeding fifty dollars for each and every offence, or be confined in the city jail from one to thirty days, or may be both fined and imprisoned as may be adjudged by the court.

Section 10.- If any person shall immoderately ride or drive any horse or other animal in any avenue, street, alley lane, or other public grounds within the limits of the Town of Deer Trail, Colorado, every such person shall, on conviction, be fined in a sum not exceeding one hundred dollars for each and every offence, or be confined in the city jail from one to thirty days, or be both fined and imprisoned, provided, however, that this section shall not be construed as prohibiting regularly organized and conducted horse racing or bucking and riding contests on the grounds of the Fair Association, or on other public places approved by the Board of Trustees.

Section 11-- It shall be unlawful for any person to strike or assault another person within the corporate limits of the Town of Deer Trail, Colorado. Any person guilty of any provisions of this section shall, on conviction thereof, be fined not exceeding fifty dollars for each and every offence, or be confined in the city jail from one to thirty days, or may be both fined and imprisoned as may be adjudged by the court.

Section 12-- It shall be unlawful for any person or persons, rail-road company or corporation to obstruct the free passage of any street or public highway within the Town of Deer Trail, Colorado, by means of any car or cars, or permit the same to remain in or upon any street or public highway across which said railroad may be constructed or operated exceeding five minutes at any time, under penalty of not more than two hundred dollars for each and every offence.

Section 13-- It shall be unlawful for any person to discharge any pistol, rifle, gun, or other firearm within the corporate limits of the Town of Deer Trail, Colorado, without the consent of the Board of Trustees of said town first having had and obtained Any person violating the provisions of this section shall be deemed guilty of misdemeanor, and upon conviction, shall be fined not less than five dollars, nor more than twenty-five dollars for each and every offence, or be confined in the city jail from one to thirty days, or may be both fined and imprisoned.

Section 14-- Any person convicted of violating any of the provisions of this ordinance and upon whom a fine and costs are imposed, shall be imprisoned in the city jail until such fine and costs are paid in no event to exceed six months. It shall be lawful for the town Marshall to cause any person confined in the town jail to engage in manual or other labor for the benefit of the town, and for each day's labor of eight hours each, the prisoner shall be given credit of two dollars to apply on fine and costs.

In the opinion of the Town Board of Trustees of the Town of Deer Trail, Colorado, an emergency exists; therefore this Ordinance which takes effect and shall be enforced from and after its passage, approval and publication in the Deer Trail Tribune, a weekly newspaper published within the corporate limits of the Town of Deer Trail, Colorado.

An ordinance repealing Ordinance No. 22 on Misdemeanors, of the Town of Deer Trail, Colorado.

Be it ordained by the Board of Trustees of the Town of Deer Trail, Arapahoe County, State of Colorado.

That Ordinance No. 22, of the Town of Deer Trail, Colorado, is hereby repealed, and declared to be null and void and of no effect, from and after the passage, approval and publication of this ordinance.

In the opinion of the Board of Trustees of the Town of Deer Trail, Colorado, an emergency exists; therefore this Ordinance takes effect and shall be enforced from and after its passage, approval and publication in the Deer Trail Tribune, a weekly newspaper published within the corporate limits of the Town of Deer Trail, Colorado.

Trustee T. H. Wobermin then introduced an ordinance on Misdemeanors, which was given the Number 24, and read by the clerk as follows:

ORDINANCE NO. 24.

AN ORDINANCE RELATING TO MISDEMEANORS.

Be it ordained by the Board of Trustees of the Town of Deer Trail, Arapahoe County, State of Colorado.

Section 1-- No person shall be drunk or in a state of intoxication in any highway, street, alley, thoroughfare or other public place within the limits of the Town of Deer Trail, nor be drunk and disorderly, or under the influence of intoxicating, malt, vinous, mixed or fermented liquors in any private or public place within the limits of said town.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 2-- If any person shall keep any room, building, arbor, booth, shed or tenement of any description, to be used or occupied for gambling, or shall knowingly permit the same to be used or occupied for gambling; or if any person being the owner of any room, building, arbor, booth, shed or tenement, of any description, shall rent the same to be used or occupied for gambling, the person so offending shall, on conviction thereof be deamed guilty of a misdemeanor.

Any person, association or corporation who shall violate any of the provisions of this section shall be fined in any sum not exceeding three hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 3-- No bawdy house, house of ill-fame, house of assignation, or place for the practice of fornication, or common, ill-governed or disorderly house, shall be kept or maintained within the Town of Deer Trail, and any person who shall keep such house, or shall be an inmate, or in any way connected with such house, or contribute to its support, and any person who shall permit any tenement, building or premises under his or her control to be used for any such purpose and any person who shall permit any building to be used or occupied for any such purpose to stand upon any lot or parcel of ground within the Town of Deer Trail, and which is owned, possessed or controlled by him or her, shall be deemed guilty of a misdemeanor.

Any person, association or corporation who shall violate any of the provisions of this section shall be fined in any sum not exceeding three hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject of both such fine and imprisonment.

Section 4-- Any prostitute, courtes an or lewd woman, who shall within the limits of the Town of Deer Trail, by word, sigh, or action attempt to ply her vocation upon the streets, or at any pbulic place, or at the door or window of the house or room she may occupy, or make any public mertricious display of herself upon the streets or in any public place in this town, or at the door or window of the house or room she may occupy, shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 5-... Any person who shall appear in any public place within the Town of Deer Trail in a state of nudity, or in any indecent or lewd dress, or shall at any place within the said town make any indecent or lewd act or behavior, or shall exhibit, sell, or offer to sell, any indecent or lewd book, picture or image, or other such thing, or shall exhibit or perform any indecent, immoral or lewd play or other representation, every such person, on conviction, shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 6-- If any person in the Town of Deer Trail shall make, countenance or assist in making any improper noise, riot, disturbance of breach of the peace, or shall use loud, profane, foul, obscene or abusive language, or language calculated or tending to provoke a breach of the peace, every such person shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 7.-- Any person who shall didturb any lawful assembly by making a noise, or by rude or indecent behavior, or by profane language or otherwise, within the limits of the Town of Deer Trail, shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of thissection shall be fined in any sum not exceeding fifty dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 8-- No person shall, within the limits of the Town of Deer Trail, carry concealed, upon or about his person, any pistol, revolver, bowie knife, dagger or other deadly weapon.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding three hundred dollars, or be imprisoned in the city jail for a period of not more than ninety days, or shall be subject to both such fine and imprisonment.

Providing further that the foregoing provisions hereof shall not apply to any sheriff, or deputy sheriff, constable, policeman or other peace officer while on duty, or to any person authorized to carry a concealed weapon by the chief of police of said Town of Deer Trail, or the sheriff of the County of Arapahoe.

Section 9-- No person shall throw a stone or other missile against or in any way deface the walls or other parts of any building or buildings, whether occupied or unoccupied, within the limits of the Town of Deer Trail, or shall in any manner injure the awnings, awning posts, fence, enclosure or other improvements of any character whatever, either public or private property, or who shall fill up, throw or place other things in, obstruct or otherwise damage any ditch or ditches lawfully constructed in said town, or who shall injure, mark, or deface any trees planted for the ornament or shade of the streets or private lots in said town, or shall cut down, disfigure, mark, deface, destroy or in any manner injure any three, shrub, plant, crops, enclosure, fence, bridge or building unless he is the owner thereof, or with the permission of the owner thereof;

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than ten days when the damage to the property shall be twenty dollars or less, or shall be subject to both such fine and imprisonment; or where the damage to the property exceeds the sum of twenty dollars shall on conviction be fined in any sum not exceeding three hundred dollars, or be imprisoned in the city jail for a period of not more than ninety days, or shall be subject to both such fine and imprisonment.

Section 10.-- No person shall suffer any drunkenness, quarreling, fighting, unlawful games or riotous or disorderly conduct on his or her premises within the limits of the Town of Deer Trail.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 11-- No person shall engage in any quarreling or fighting, nor shall ask or invite or defy any person to fight or quarrel, nor shall engage in any dog, cock or other fights within the bounds of the Town of Deer Trail, either in any of the streets, avenues, commons or on any vacant lot, or upon any lands or under any shed or in any building or apartment or enclosure or upon any bridge or upon any place, public or private.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 12- No persons shall, within the limits of the Town of Deer Trail, collect together in bodies or crowds for unlawful purposes, or for any purpose to the annoyance or disturbance of the citizens or travelers thereof.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 13-- If any person shall immoderately ride or drive any horse or other animal in any avenue, street, alley, lane or other public grounds within the limits of the Town of Deer Trail, every such person shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 14.-- If any person shall leave any horse or other work or driving animal attached to any carriage, wagon, cart, sleigh, sled or other vehicle, in any street, avenue, alley or other thoroughfare within the Town of Deer Trail, without securely fastening the same, or with the same being fastened by a chain, rope or strap from the bit to a metal weight upon the ground, such weight weighing at least ten pounds for a team, shall be deemed guilty of a misdemeanor.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 15.-- No person shall strike or assault another person within the limits of the Town of Deer Trail.

Any person who shall violate any of the provisions of this section shall be fined in any sum hot exceeding one hundred dollars, or be imprisoned in the city jail for a period of not more than thirty days, or shall be subject to both such fine and imprisonment.

Section 16-- It shall be the duty of the engineer or other person in charge of any locomotive engine, while running within the limits of the Town of Deer Trail, to ring the locomotive bell sufficiently loud to warn all persons of the approach of such locomotive engine.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding two hundred dollars, or be imprisoned in the city jail for a period of not more than sixty days, or shall be subject to both such fine and imprisonment.

Section 17.-- No person or persons, railroad company or corporation to obstruct the free passage of any street or public highway within the Town of Deer Trail, by means of any railroad car or cars, or locomotive engine, or permit the same to remain in or upon any street or public highway across which said railroad may be constructed or operated, exceeding five minutes at any one time.

Any person or corporation who shall violate any of the provisions of this section shall be fined in any sum not exceeding two hundred dollars or be imprisoned in the city jail for a period of not more than sixty days, or shall be subject to both such fine and imprisonment.

Section 18.-- It shall be unlawful for any person to herd, or cause to be herded any cow, cattle, horse, sheep or other animal or animals upon any of the streets, alleys, vacant lots or upon any public ground within the limits of the Town of Deer Trail.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding twenty five dollars for each offense.

Section 19-- No person shall intentionally give a false alarm of fire in the Town of Deer Trail.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding twenty five dollars for each offense.

Section 20.-- It shall be unlawful for any person to discharge any pistol, rifle, gun, or other firearm within the limits of the Town of Deer Trail, without the consent of the Board of Trustees of said town first having had and obtained in writing.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding fifty dollars, or be imprisoned in the city jail for a period not exceeding thirty days, or by both such fine and imprisonment.

Section 21.-- It shall be unlawful for any railroad or street railway company or corporation, or any person or persons in their employ to move, propel or cause to be moved, propelled or driven any railroad or street car or locomotive engine on any portion of the railroad or railway of such company or corporation within the limits of the Town of Deer Trail at a rate of speed exceeding fifteen miles an hour.

Any person or corporation who shall violate any of the provisions of this section shall be fined in a sum not less than fifty dollars nor more than two hundred dollars, or be imprisoned in the city jail for a period not exceeding sixty days, or by both such fine and imprisonment.

Section 22-- No person while under the influence of intoxicating liquor in any degree shall drive any kind of vehicle on the streets or public thoughfares of the Town of Deer Trail.

Any person who shall violate any of the provisions of this section shall be fined in a sum of not less than five dollars nor more than three hundred dollars, or be imprisoned in the city jail for a period not exceeding ninety days, or by both such fine and imprisonment.

Section 23-- No person, association or corporation shall, within the limits of the Town of Deer Trail, manufacture for sale or gift any intoxicating liquors; and no person, association or corporation shall within the limits of the Town of Deer Trail, sell or keep for sale any intoxicating liquors or offer any intoxicating liquors for sale, barter or trade; and no person, association or corporation shall keep or have in his or its possession, for personal use or otherwise, any intoxicating liquors or permit another to have or keep or use intoxicating liquors on any premises owned or controlled by him, or give away or furnish any intoxicating liquors to another; provided however that intoxicating liquors may be handled for medicinal and sacramental purposes only, in the manner prescribed by the laws of the State of Colorado.

Any person who shall violate any of the provisions of this section shall be fined in any sum not exceeding three hundred dollars and not less than one hundred dollars, or by imprisonment in the city jail for a period of not less than thirty days nor more than ninety days, or by both such fine and imprisonment.

Section 24.-- Upon the rendition of any judgment against any defendant for the violation of any ordinance mentioned in this act, all the costs shall also be taxed against such defendant, and the Police Magistrate shall commit such defendant to the city jail or other place of confinement provided for that purpose, until such fine, costs and penalties are fully paid, provided that no fine shall exceed the sum of three hundred dollars and no imprisonment shall exceed ninety days for any one offence. All persons committed as aforesaid shall so far as practicable be required to work for the town at some useful work as his or her strength will permit within or without the places provided for imprisonment. During the time any person is working out his fine, forfeiture or penalty as provided herein he shall each night be committed for safe keeping to the city jail or other place of confinement provided for that purpose. Every person so employed to work as herein provided shall be allowed exclusive of his or her board the sum of two dollars per day of eight working hours on account of such fine and costs.

In the opinion of the Board of Trustees of the Town of Deer Trail, Colorado, an emergency exists; therefore this Ordinance takes effect and shall be enforced from and after its passage, approval and publication in the Deer Trail Tribune, a weekly newspaper published within the corporate limits of the Town of Deer Trail, Colorado.

ORD INANCE NO. 25

An ordinance relating to lights on motor cars, and prohibiting gambling.

Be it ordained by the Board of Trustees of the Town of Deer Trail, Arapahoe County, State of Colorado.

Section 1.-- Any motor car, automobile, or other vehicle, propelled by gas, gasoline, electricity, or steam, running on the streets of the Town of Deer Trail, shall display two lights at the front of such vehicle as headlights, one-half hour after sunset and continuously thereafter until dawn, while running on the streets within the corporate limits of said town, and any motorcycle shall display one headlight, all such headlights on motor cars and motor-cycles to be equipped with dimmers which shall be used on approaching another vehicle on said streets.

All motor cars and motorcycles shall display a red light at the rear of such car, so placed as to be plainly visible to any one approaching from the rear, and such rear light shall be so arranged as to cast a white light on the license tag of said motorcycle or motor car.

Any person who shall violate any of the provisions of this section shall on conviction, be fined in any sum not under \$10.00 nor exceeding \$60.00.

Section 2.-- No person shall play at any game whatsoever for any sum of money or other property of value, or shall make any bet or wager for any sum of money or other property of value upon result of such game, within the corporate limits of the Town of Deer Trail, either on public or private property.

Every such person shall on conviction thereof, be fined in any sum not less than \$50.00 nor more than \$150.00.

Section 3.-- No person, firm or corporation shall keep for sale or public use, any punch board, slot machine, or other gambling divice whereon games may be played for money or other property of value, within the corporate limits of the town of Deer Trail.

Any person, firm or corporation violating any of the provisions of this section shall on conviction be fined not less than \$10.00 nor more than \$100.00.

In the opinion of the Board of Trustees of the Town of Deer Trail, Colorado, an emergency exists; therefore this Ordinance takes effect and shall be enforced from and after its passage, approval and publication in the Deer Trail Tribune, a weekly newspaper published within the corporate limits of the Town of Deer Trail. Colorado.

1. Party of the first part hereby employs party of the second part in his capacity as Engineer, for the construction of a Water Works system in the Town of Deer Trail, Colo.

2. Party of the second part agrees to design the supervise the construction of a water works system and to protect the interests of the party of the first part in every way, and to be responsible in every detail for the delivery to the party of the first part, a complete, well designed, and well constructed water works system.

3. Party of the second part hereby agrees to work under the direction of of the City Council of Town of Deer Trail and to be subject to its direction and orders.

4. Party of the second part agrees to employ a competent inspector or inspectors, as the work may require. And for any act of disloyalty, dishonesty, or incompetency, party of the first part may direct party of the second part to discharge such inspector or inspectors and to furnish inspector or inspectors subject to the approval of the part of the first part.

5. Party of the first part agrees to pay party of the second part 8% per cent of the contract price of the completed water works system for his engineering services.

6. Party of the second part, for the fee above stated, agrees to do all surveying, designing, supervision and inspection and to pay his own traveling expenses required in the construction and completion of the water works system.

7. If for any unforseen cause no contract should be let for the construction of the proposed system then the part of the first part shall pay nothing to the party of the second part for the expenses incurred by party of the second part in preparing the plans and specifications and securing bids on the construction of the system.

8. Payment of the engineering fee stipulated in paragraph five (5) of this contract shall be paid to party of the second part in the same manner as payment shall be made to the contractor under the contract between the town and the contractor.

9. All advertisements for bids, or printing or publications of any kind shall be paid for by party of the first part.

IN WITNESS WHEREOF, the party of thefirst part has caused this contract to be signed by its Mayor and attested to by its Town Clerk with the Corporate Seal of The Town of Deer Trail and the party of the second part has signed his name this 6th day day of Dec. 1921.
