ORDINANCE NUMBER 32.

CONCERNING POOL AND BILLARD HALL OPERATING IN TOWN OF DEER TRAIL, COLORADO.

Be it ordained by the Mayor and Board of Trustees of the Town of Deer Trail, Colorado.

Section 1.

水

That it shall be lawful to run, operate, or own a Pool or Billiard Hall, or Parlor, within the corporate limits of Deer Trail, Colo.; subject to the following rules and regulations governing the same.

Section 2. LICENSE AND FEE:

That any one desiring to operate, run, manage a Pool and Billiard Hall in said Town must have consent and permission of the MAYOR and the Honorable Board of Trustees of said Town.

If permission is granted, a license shall then be obtained from the Clerk of said town, the License to be not less than \$25.00 per annum, and not to excede a tax of \$10.00 on each and every table operated therein.

Section 3. AGE LIMIT. TIME REULATIONS AND ETC.

It shall be unlawful for any one running or operating a Pool and Billiard Parlor in the said Town to allow or permit any person under the age of 18 years, unless they obtain a satisfactory permit from their Parents, to play Billiards, Pool, or to loaf or Loiter in the Pool or Billiard Hall.

The Pool Hall or Billiard room not to be opened for business before the hours of 6 A. M. and to close up not later than 12:00 P. M. each day except Sunday, then the hours shall be from 1:00 P. M. until 10:00 P. M. except for the sale of Soft drinks, cigars, tobacco, candy and other confections usually kept for sale therein.

Section 4, PENALTY

¥

Any person violating any provision of this ordinance, shall be fined not less than \$5.00 or over \$25.00 at the descretion of the court: also the license may be revoked for the violating of; any of the above provisions or both fined and license revoked.

It was decided unanimously by the board that the offer of the Light Plant scacepted to furnish cinders to improve crossings in town, Town to do the hauling.

It was moved by Trustee A. M. Sniff, seconded by J. T. Carmack, that the Town of Deer Trail put up as much money to pay for the search for the gun used by the murderer of Howard Hamilton, as the county puts up.

The Board appointed the Town Marshal to conduct the search for said gun.

Trustee D. M. Titus suggested that the marshal investigate the show going on in the Farmer's Union Hall, and if same should be subject to license under the Ordinances of the Town, that a fee of \$5.00 be collected from the management of said show.



Section 5. That said bonds, when executed, shall be delivered to the purchaser thereof, and said bonds and the funds raised thereby shall be applied solely and exclusively for the purpose aforesaid, the construction of waterworks for fire and domestic purposes within and for said Town, and for no other purpose whatsoever, but the purchaser of said bonds shall in no manner be responsible for the application or disposal by said Town or any of its officers of any of the funds derived from the sale thereof.

Section 6. That the interest falling due on said bonds on January 1, 1924, shall be paid out of the general revenue fund of the Town, and for the purpose of reimbursing said general revenue fund for said installment of interest and to meet the interest accruing on said bonds after January 1, 1924, and for the purpose of creating a sinking fund for the ultimate redemption of said bonds, there shall be levied on all of the taxable property in said Town, in addition to all other taxes, direct annual taxes, as follows:

> In the year 1923 a tax sufficient to produce the sum of \$3,300.00 for interest.

In each of the years 1924 to 1931, inclusive, a tax sufficient to produce the sum of \$2,200.00 for interest.

In each of the years 1932 to 1936, inclusive, a tax sufficient to produce the sum of \$10,200.00, being \$2,200.00 for interest and \$8,000.00 for principal.

In the year 1937 a tax sufficient to produce the sum of \$1,100.00 for interest.

Said taxes, when collected, shall be applied solely to the purpose of the payment of the said interest and the principal of said bonds, respectively, and for no other purpose whatever, until the indebtedness so contracted, under this ordinance, both principal and interest, shall have been fully paid, satisfied and discharged, but nothint herein contained shall be so construed as to prevent said Town from applying any other funds that may be in the Town treasury and available for that purpose to the payment of said interest or principal, as the same respectively mature, and the

levy or levies herein provided for may thereupon to that extent be diminished.

And the sums hereinbefore provided for to meet the interest on said bonds and to discharge the principal thereof when due, are hereby appropriated for that purpose, and said amount for each year shall also be included in the annual appropriation bills passed by the board of trustees of said Town in eachygar respectively.

Section 7. It shall be the auty of the board of trustees of said Town, annually, at the time and in the manner provided by law for levying other town taxes, if such action shall be necessary to effectate the provisions of this ordinance, to ratify and carry out the provisions hereof with reference to the levying and collection of taxes; and shall require the officers of and for said Town to levy, extend and collect such taxes in the manner provided by law for the purpose of creating a fund for the payment of the principal of said bonds, and interest thereon, and such taxes, when collected, shall be kept for and applied only to the payment of the interest and principal of said bonds as hereinbefore specified.

Section 8. After said Town has constructed the said water system, the same shall be managed and operated by the said Town, and all water taxes, rents and rates for water furnished and used therefrom shall be directly collected by the said Town and used in such manner as shall be provided by ordinance, and the proceeds of such taxes, rents and rates, together with all income therefrom, including the plumbing and tapping of mains and laying and connecting supply pipes thereto, shall be used first to defray the running expenses of such waterworks, and to keep the same in repair; second, for extending the mains thereof and making additions thereto whenever in the opinion of the board of trustees of said Town, such extensions, improvements and additions shall be necessary and expedient, and shall have been ordered by a majority vote of **all** of the members of said board of trustees; and the balance of the said income from said waterworks, after paying the running expenses, repairs, extensions, improvements and additions, shall constitute a sinking fund for the payment of the principal and interest on said bonds.

Section 9. After the construction of the said plant, the tapping of the mains thereof for the purpose of attaching the pipes thereto, and the laying of such pipes for supply, and the digging of trenches therefor from the main to the sidewalk and in placing stops therein whenever the same shall be required, shall be done only by the employes of the Town, engaged for that purpose, and the proceeds derived therefrom shall be considered as income from said waterworks and shall be applied to the interest and redemption fund as herein provided for; and no contract shall be made with, nor permission given any person, company or corporation to pap the mains, or lay any supply pipes, or run or operate the said waterworks system otherwise than as herein specified.

Section 10. All ordinances, by-laws and regulations of the Town of Deer Trail in conflict with this ordinance are hereby repealed.

Section 11. After said bonds are issued this ordinance shall be and remain irrepealable until said bonds and the interest thereon shall have been fully paid, satisfied and discharged, as herein provided.

Section 12. By reason of the fact that said Town is not properly or adequately supplied with water, it is declared that an emergency exists, and that this ordinance is necessary to the immediate preservation of the public peace, health and safety, and shall be in full force and effect five days after publication.

That the Weiland Engineering Company be, and they are hereby authorized and directed to proceed with surveys of that portion of the Town of Deer Trail to be included within the proposed boundaries of said Deer Trail Sanitary Sewer District No. 1, and that it file with the Town Clerk details of such survey, consisting of the specifications for the improvement to be constructed in said proposed district, its estimates of the cost of such improvement, maps of the proposed district showing its exterior boundaries and all streets, avenues, alleys, public places, lots and blocks within the same, its schedule showing the approximate amount of said cost to be apportioned to and assessed upon each lot or parcel of land in said district, such cost to be apportioned and assessed upon each lot or parcel of land in said district in proportion to the benefits accruing thereto, all such apportionments and assessments to be estimated and made in accordance with the provisions of "An Act Relating to Local Improvements in Cities and Towns," approved April 9, 1923.

All of said matters and documents shall be properly indexed for the purpose of identification and shall be signed by said engineering company.

Mr. Peterson was advised of the present fire limits, and on consulting the fire map, it was decided that none of the locations now under consideration for the proposed creamery came within the fire limits, and therefore no action was necessary on the part of the board.

There being no further business, the meeting adjourned.

Minutes of adjourned regular meeting of the Board of the Trustees of the Town of Deer Trail, held December 19th, A. D. 1923, at 8:00 P. M. held in the offices of The Deer Trail State Bank, by agreement of Trustees.

There being a quorum present, the following business was transacted.

Thereupon the following resolution was presented, considered and unanimously adopted, all trustees present voting "aye" with exception of Trustee H. V. Leonard, on the adoption thereof:

#### <u>R B S O L U T I O N</u>.

Adopting Details and Specifications for an Improvement District in the Town of Deer Trail, to be known as Sanitary Sewer District No. 1, Deer Trail Colorado, and ordering publication of Notice to the Owners of the Property to be assessed for said Sewer Improvement in said District.

WHERMAS, by a resolution passed and adopted at an adjourned regular meeting of the Board of Trustees of the Town of Deer Trail, held on the 4th day of December A. D. 1923, a preliminary order was made for the creation of an improvement district in the Town of Deer Trail, to be known as Sanitary Sewer District No. 1, and directing the Teiland Engineering Company to make the necessary preliminary surveys, estimates and maps as required by the provisions of "An Act Relating to Local Improvements in Cities and Towns," approved April 9, 1923; and,

WHEREAS, the said company, in pursuance of the orders in said resolution made, have reported to this Board of Trustees the completion of all matters and things in said resolution enjoined upon them in the form and manner as therein directed, all of said data being now on file with the Town Clerk in completed form and substance as by said orders and by law required:

WHEREFORD, BE IT RESOLVED by the Board of Trustees of the Town of Deer Trail:

1. That said engineers' report, together with the details, specifications, estimates, maps and schedules prepared and filed with the Clerk of the town, be, and the same are, hereby approved and adopted by this Board of Trustees for use in the construction of the improvements to be made in said Sanitary Sewer District No. 1, Deer Trail, Colorado.

2. That the material for said improvement shall be as follows: approxamately 5200 lineal feet of 10" sewer pipe. 5500 lineal feet of 8" sewer pipe 4320 lineal feet of 6" sewer pipe, 29 concrete manholes, 4 flush tanks together with all other appurtenances for a complete sewer system ready for service.

3. That the assessments to be levied shall be due and payable within thirty days from and after the publication of the assessing ordinance, assessing the whole actual cost of said improvements against said real estate; provided, however, that any owner who shall pay his full assessment within said period of thirty days, shall be entitled to an allowance of five per cent. of the amount so assessed against his property and paid by him; or in case any owner of real estate shall fail to pay the whole of such assessment against his property within said thirty days, then the whole cost of said improvements so assessed against his property, shall be payable in twenty equal annual installments of principal, with interest on unpaid installments, at the rate of six per centum per annum, payable semi-annually; the first of said installments of said principal shall be due and payable at such time as may be determined in and by the assessing ordinance, and the remainder of said installments shall be due and payable successively on the same day in each year thereafter until all are paid in full.

4. That the property to be assessed for said improvement shall be the property within the district more particularly described in the notice hereinafter set forth, except streets and alleys.

5. That the attorneys for the town be, and they are hereby authorized and directed to prepare an ordinance in conformity with, and under the provisions of, an Act of the General Assembly of the State of Colorado, entitled: "An Act Relating to Local Improvements in Cities and Towns," approved April 9, 1923, creating within the corporate limits of the said Town of Deer Trail, a local improvement district to be known as Sanitary Sever District No. 1, and providing in and by said ordinance for the construction in said district of the said improvements in accordance with the report, plans, maps, specifications, details and estimates of the engineers of said town herein referred to and now on file in the office of the Town Clerk; and providing that the Mayor and Town Clerk may advertise for bids for the construction of said improvements as required by law.

6. That the said proposed ordinance be considered for passage and adoption by this Board of Trustees at 7:30 o'clock PP M., on the 11 day of Jan. A. D. 1924.

7. That notice be issued by the Town Clerk and published in the Deer Trail Tribune, a newspaper of general circulation in said town, at least once a week for three consecutive weeks, therein giving notice to the owners of the property to be assessed, of the matters and things required by law, which notice shall be in substantially the following form, to-wit:

## NOTICE

OF A PROPOSITION TO OREATE A LOCAL IMPROVE-MENT DISTRICT IN THE TOUTH OF DEFER TRAIL, TO BE KNOWN AS SANITARY SEVER DISTRICT NO. 1, AND TO MAKE CERTAIN SEVER IMPROVEMENTS IN SAID DISTRICT.

All owners of the real estate and property within the district hereinafter described, and all persons generally, are hereby notified that the Board of Trustees of the Town of Deer Trail, in the County of Arapahoe and State of Colorado, pursuant to the laws of the State of Colorado, has adopted full details, plans and specifications for the construction of certain sewer improvements in and for a proposed local improvement district within the corporate limits of the Town of Deer Trail, to be known as Sanitary Sewer District No. 1. Said persons are further notified as follows:

(1) The kind of improvement proposed is the construction of district sanitary sewers, to connect with natural drainage.

(2) The assessment for said improvements may be paid in twenty equal annual installments.

(3) That the said assessments will be due and payable without demand within thirty days from and after the publication of the ordinance assessing the whole cost of said improvements against the real estate in said district; provided, however, that any owner who shall pay his full assessment within said period of thirty days, shall be entitled to an allowance of five per centum; or in case any owner of real estate shall fail to pay the whole of such assessment against his property within said thirty days, then the whole cost of said improvement so assessed against his property shall be payable in equal annual installments of principal, as aforesaid; the first of such installments of said principal will be due and payable at such time as may be determined in and by the assessing ordinance, and the remainder of said installments shall be due and payable successively on the same day in each year thereafter until all are paid in full.

(4) The rate of interest to be paid on unpaid and deferred installments shall be six per cent. per annum, payable semi-annually.

(5) The district to be improved is described as follows:

Beginning at a point; said point being the intersection of the center lines of Fifth Street and Fifth Avenue; thence Southeasterly along the center line of Fifth Avenue to the intersection of the center line of Second Street; thence Southwesterly along the center line of Second Street to the intersection of the center line of Fourth Avenue; thence Southeasterly along the center line of Fourth Avenue to the intersection of the center line of First Street; thence Southwesterly along the center line of First Street to the intersection of the center line of Second Avenue; thence southeasterly along the center line of Second Avenue to the intersection of the center line of Burton Street; thence southwesterly along the center line of Burton Street to the center line of First Avenue; then Northwesterly along the center line of First Avenue to the intersection of the center line of Fourth Street; thence Southwesterly \*at right angles to the Union Pacific Railway right-of-way and across said rightof-way along the center line of Fourth Street produced a distance of 440 feet; thence Northwesterly on a line parallel to First Avenue a distance of 960 feet; thence Northeasterly at right angles to the Union Pacific R allway right-of-way. and across said right-of-way along the center line of Sixth Street produced a distance of 440 feet to the intersection of the center lines of First Avenue and Sixth Street; thence Northwesterly along the center line of First Avenue to the intersection of the center line of Ninth Street; Thence Northeasterly along the center line of Ninth Street to the intersection of the center line of Third Avenue; thence Southeasterly along the center line of Third Avenue to the intersection of the center line of Sixth Street; thence Northeasterly along the

(6) As shown by the estimates of the engineers, the probabbe total cost of said improvements is twenty three thousand five hundred dollars (\$23,500.00), and the probable cost per square foot of district area is \$00773, including cost of inspection, collection and incidentals and also the first years interest on the bonds to be issued, as provided by law.

Property owners are specifically referred to the schedule of estimated assessments on file in the office of the Town Clerk, from which the amount proposed to be assessed against any particular piece or parcel of property may be definitely determined.

(7) An ordinance authorizing said improvement will be considered by the Board of Trustees on the 11 day of Jan. A. D. 1924, at the hour of 7:30 o'clock P. M., or at an adjourned meeting thereafter.

(8) That a map, estimate and schedule showing the approximate amounts proposed to be assessed on all the property in said district, and all resolutions and proceedings are on file and can be seen and examined by any person interested at the office of the Town Clerk at any time prior to the 10 day of Jan. A. D. 1924.

(9) That all complaints and objections that may be made in writing concerning the proposed improvements, by the owner or owners of any real estate to be assessed, will be heard and determined by the Board of Trustees at a meeting in the town hall, in said town, on the 10 day of Jan.
